Message from Chair of PCV and CEO

The overarching Vision of Palliative Care Victoria is that all people with a life limiting illness and their families are supported to live, die and grieve well, and our Mission is to advance our vision through empowering leadership, capacity building and advocacy.

This year we have continued to do just that, working with commitment and passion across Victoria, with the aim that those living with a life limiting illness have knowledge, understanding and access to palliative care regardless of age, ethnicity, sexuality, disability or location.

The COVID-19 pandemic that we are all living through provides many challenges for people requiring palliative care, and for their families. Making decisions about the place of care and support has become increasingly complex as Victoria moves through its various stages of restrictions. Health care professionals have also become increasingly challenged to deliver a COVID-modified approach to palliative care. The model of care has often needed to be very different to the ideal that palliative care clinicians have trained for and strive to achieve.

Palliative Care Victoria has continued to deliver its strategic plan supporting palliative care recipients and care givers, volunteers and health care professionals, with direct one-to-one information and support via our amazing and dedicated team. Our weekly Newsflash has become a key dissemination point for information, including COVID specific palliative care research and updates to our membership. Whilst face-to-face community engagement has transitioned to online meetings, the attendance and frequency of engagement has continued to increase and PCV now reaches more Victorians than ever before.

We continue to advocate for and represent our membership in State and National forums in relation to challenges that the pandemic brings for those requiring or delivering palliative care. We work closely with both Safer Care Victoria and the Victorian Department of Health and Human Services, and with Palliative Care Australia to advocate for State and Commonwealth Government support for palliative care. This financial year has seen a significant change in PCV leadership: Odette Waanders resigned from her position as CEO after a dedicated service of almost a decade; Annie Revell provided stability as the interim CEO for eight months whilst a national recruitment campaign occurred; and Violet Platt joined as the new CEO in June 2020. We thank Odette and Annie for their leadership, dedication and support given to PCV during their respective tenures.





Specialist palliative care benefits individuals and health services

Advocacy and government relations

We continue to advocate for increased palliative care funding for Victorians. Outgoing CEO, Odette Waanders aligned with the 2019 World Hospice and Palliative Care Day campaign "My Care, My Right". This advocacy highlighted the need to continue the building of palliative care supports and services across Victoria, to ensure equitable access to palliative care, for all Victorians with a life limiting illness and their families, when and where they need it.

We contribute to the development of National Palliative Care Policies, ranging from Aged Care to COVID submissions as a member of PCA's National Expert Advisory Committee. We continue to support Policy and Service development initiatives in partnership with Victorian Department of Health and Human Services and service providers, bringing the perspective of many communities to the developments.

We have the collective voice of 184 members from across Victoria, 94 of these are organisational members. PCV members include health professionals from all sectors of health care, specialist and generalist palliative care services, aged care, disability care, health research, consumers and interested community members. Collectively, the PCV membership provides a comprehensive source of palliative care knowledge and wisdom which can be utilised to influence the effective delivery of palliative care across Victoria.

Member feedback and engagement

Our weekly Newsflash publication continues to be the main source of information to members and is well received by health professonals, academics, researchers and volunteers across the sector. We are grateful for all the members who share information for Newsflash.

We were able to change work practice during COVID-19 to working from home quickly and without any impact to information requests. During this year 626 requests for information were answered. Top reasons for contacting us included information about palliative care services and requests for resources and publications.

Building connections and capacity

For National Palliative Care Week beginning Sunday 24th May 2020, we launched a video-based community awareness campaign to educate about, and celebrate palliative care, with the theme "Palliative Care: it's more than you think". The campaign:

- highlighted examples of palliative care from individual workers and volunteers, helping people to live, die or grieve well.
- showcased the importance of palliative care and the importance of its integration into all care.
- championed the highly skilled and committed people who work and volunteer in the palliative care sector.
- recognised ethnic community support for people with palliative care needs.

We appreciate the contribution of the PCV community who provided 48 videos, which were used for this campaign in a series of YouTube videos and Facebook posts. During Palliative Care Week alone 19 Facebook posts reached 78,961 people and the YouTube videos were uniquely viewed 72,031 times. They remain available for everyone:

Empowered consumers

We continue to build on the 2019 "Moments That Matter Campaign" taking the Values Compass into the community whenever the opportunity arises. At the Springvale Indo-Chinese Mutual Assistance Association Health and Well-being Festival, over 40 participants completed the worksheet. The intent is to encourage us all to live life more fully by focusing on what matters most, and identifying them in our personal values compass. This provides an opportunity to reflect on what's important. The Values Compass is available on our website and is useful for self-reflection and initiating discussions about someone's palliative care wishes.

New consumer resources

In December 2019, at a CALD community meeting, PCV staff noticed the interest in palliative care services increased when the conversation shifted to its practical benefits.

Palliative Care Australia and Palliative Care Victoria decided in January 2020 to generate a one page Fact Sheet describing the practical benefits of palliative care services. The Fact Sheet content was validated by seven specialist palliative care services in metro and country Victoria.

Twenty-one language groups were identified representing established and emerging ethnic populations across urban and rural Victoria. They agreed to translate the Fact Sheet and hold consultation/focus groups.

Over the next three months each language group shared their perspective and prioritised the list according to importance within their cultural context. Consequently each language Fact Sheet has the same content, but services are ranked differently.

Over 300 community representatives across the 21 language groups contributed to develop the resource and improved their understanding of services and support provided by palliative care. Most are in a position to have an ongoing influence in their community in relation to care options at end of life.

Diversity inclusive and diversity responsive palliative care

Capacity building for ethnic aged care workforce

In June 2019, PCV consulted individually with 17 ethnic community partner organisations engaged in aged care service provision to determine capacity building needs relating to caring for people with a life-limiting illness. As a result, three capacity building workshops were organised in partnership with Australian Vietnamese Women's Association, Co.As.It. and Victorian Arabic Social Services for a total of 52 staff and volunteers in ethnic aged care programs. Topics selected by the communities were: Recognising Deterioration, Palliative Care Conversations and Palliative Massage Therapy.

Culture-Centred Care Training for Victoria's healthcare professionals

Through the Program of Experience in Palliative Approach (PEPA), PCV in partnership with Judith Miralles and Associates facilitated Culture-Centred Care Workshops with new content and a training video. Approximately 70 clinicians attended four workshops held in Camperdown, Bendigo, Dandenong and Morwell. PCV received excellent feedback about content and facilitation.

Promoting community initiatives

PCV supported initiatives from ethnic communities such as:

- Training and capacity building programs for the Serbian, Spanish Latin American and Ethiopian communities to provide psychosocial support and enable access to health services for people with a chronic/terminal illness. Eight staff from the Latin American and Ethiopian organisations visited Mercy Palliative Care, Sunshine for a briefing on specialist PC services.
- The South Eastern Region Community Palliative Care Network was set up by the Southern Migrant and Refugee Centre. This network began in February 2020 and includes representation from ethnic groups, City Councils and specialist palliative care services.

Participation in community programs to enhance engagement

- PCV is a member of the Advisory Group for Hand in Hand Project, a state-funded End of Life Care program of Multicultural Centre for Women's Health.
- PCV participated in community partner events such as the Springvale Indo-Chinese Spring Festival, West Care office launch by Chinese Cancer and Chronic Illness Society, AGMs of Spiritual Health Association, Australian Vietnamese Women's Association and Ethnic Communities Council of Victoria.
- PCV gave a brief presentation at the Knox Interfaith Forum on Death and Dying.
- PCV gave a brief presentation at the Knox Policy Group of Ethnic Communities Council of Victoria.

Community education sessions

'Introduction to palliative care' sessions were held for approximately 115 persons representing leaders from the Bilal, Oromo, Harar communities originally from Horn of Africa, spiritual carers from Hindu Council of Australia; CHSP and HACC providers from Port Philip City Council; Cardiac support group of PRONIA, Home Care Program Workers of Australian Vietnamese Women's Association.

Serbian volunteers provide in-language palliative support

Milena (not her real name), 92, has lived in an aged care facility with her husband for the last few years. As a palliative care resident, she was eligible to receive a palliative support volunteer from the Serbian Community Association of Australia, to visit her on a weekly basis. Within a few months Milena and the volunteer became very close and developed a strong friendship. Unfortunately, Milena's husband passed away during the COVID-19 pandemic, and his death caused so much grief to Milena that she requested the lifestyle coordinator assist her to contact her volunteer. As visits were not allowed, the volunteer phoned Milena and they spoke for almost two hours, with the volunteer listening to and comforting her. The volunteer continues to call regularly and, although still grieving, Milena is glad to share her life story and feelings with her Serbian volunteer.

'Beyond Words' Volunteer Biography Program



Establishing a Volunteer Biography Program had long been a dream for J Cawton, Volunteer Services Manager at Hepburn Health Service. A scholarship from Palliative Care Victoria enabled her to attend training with Eastern Palliative Care to set up a Volunteer Biography Program.

After several months of work preparing Biographer Handbooks, training notes and forms, the Hepburn Health 'Beyond Words' Volunteer Biography Program was born and four volunteers were trained.

Debbie Rauber, one of the volunteers in Lumeah Lodge in Daylesford, asked resident Ken Smith if he'd be her 'Guinea Pig'. Of course Ken, ever the volunteer, said, "Yes. But mine's just an ordinary life." And so Ken's biography was born. He shared his stories about his lifelong love for his dear Pat, whom he was married to for 58 years. Ken showed so much pride in his boys – Peter and Kevin and much love for his grandchildren.

By the end of 2019, after several months of visits with Ken, recording, transcribing and editing, Debbie presented the first completed 'Beyond Words' Program biography entitled 'Just an Ordinary Life' to Ken. Ken's son Kevin was helpful throughout the process finding photos and checking dates and other details. The biography presentation was a special moment for Ken and Kevin, Debbie and J (pictured above).

Expanded, innovative and valued volunteering

Collaboration

PCV's presentation Many hands: Palliative Care Volunteer Training for aged care services at the Oceanic Palliative Care Conference in Perth focused on upskilling volunteers based on PCV's updated Palliative Care Volunteer Training Resource Kit.

PCV's popular Volunteering Newsflash sent to an average of 675 subscribers received positive feedback.

Through our participation in network meetings and AGMs we fostered relationships with Volunteering Victoria, Leaders of Health Volunteer Engagement (LoHVE) and Council on the Ageing (COTA) Victoria.

We commenced a collaboration with the Victorian Advocacy League for Individuals with Disability (VALID) to develop posters and brochures in Easy English about palliative care, death and dying, grief and loss.

Capacity building

We facilitated an education session about palliative care, grief and loss and self-care for 12 participants from Polish Community Council Victoria (PCCV).

We held three face-to-face network meetings for managers of palliative care volunteers in metro and regional Victoria. These were coupled with workshops on values based leadership and critical reflection. Due to COVID-19, three more meetings were facilitated via zoom to continue collaboration, support and information sharing. Overall, 40 managers from 34 organisations attended network meetings.

PCV-trained volunteer facilitators conducted two information sessions about palliative care with very engaged community groups.
